### GUIDELINES AND INSTRUCTIONS FOR ADMISSION TO B.V.Sc. & A.H., B.Tech (D.Tech) AND B.F.Sc., DEGREE PROGRAMME UNDER NRI QUOTA OF KVAFSU, BIDAR

"FOREIGN NATIONALS (FN), NON-RESIDENT INDIAN (NRI), NON-RESIDENT INDIAN CHILDREN (NRI's-C) and NON-RESIDENT INDIAN SPONSORED (NRI-S)"

#### **ELIGIBILITY:**

- 1. Admission to Bachelor of Veterinary Science & Animal Husbandry (B.V.Sc. & A.H.): The candidate should have passed 12th Standard / PUC or its equivalent examination with a minimum score of 50% aggregate marks in the subjects of Physics, Chemistry, Biology (Botany and Zoology) / Biotechnology and English.
- 2. Admission to Bachelor of Technology in Dairy Technology [B.Tech (D.Tech)] and Bachelor of Fisheries Science (B.F.Sc.): The candidate should have passed 12<sup>th</sup> Standard / PUC or its equivalent examination in the subjects of Physics, Chemistry, Mathematics and Biology (Botany and Zoology) and English.

#### AGE LIMIT:

The candidate should have attained the age of 17 Years as on 31.12.2021 and should not have completed 25 years of age as on 31.12.2021. No relaxation of Minimum and Maximum age limit is permissible on any grounds.

#### MODE OF APPLICATION:

The candidate has to submit separate "ON-LINE" applications for B.V.Sc. & A.H., B.Tech (D.Tech) and B.F.Sc., degree programmes. A separate application fee of ₹ 10,000/- (Indian rupees) must be remitted through online for each application.

### SELECTION OF CANDIDATES FOR ADMISSION:

- 1. B.V.Sc. & A.H.: Admission to B.V.Sc. & A.H degree programme shall be purely based on the NEET score (conducted by National Testing Agency) for the candidates under NRI / NRI's-C seats and CET Score (conducted by Karnataka Examination Authority only) for the candidates under NRI-S seats in the subjects of Physics, Chemistry and Biology. Foreign Nationals are selected purely based on 12th Standard / PUC or its equivalent examination in the subjects of Physics, Chemistry, Biology (Botany & Zoology) / Biotechnology and English.
- 2. B.Tech (D.Tech) and B.F.Sc.: The admission shall be based on the merit scored by the candidate in the subjects of Physics, Chemistry, Mathematics and Biology (Botany and Zoology) in the qualifying examination.

- 3. Admission of the candidates shall be in the order of Foreign Nationals (FN) followed by Non-Resident Indian (NRI), and Non-Resident Indian Children (NRI's-C).
- 4. If the seats are not filled by the above categories such seats shall be filled by the NRI-S candidates, which are exclusively earmarked for the students of Karnataka domicile.
- 5. Selected candidates may exercise their choice for opting of college, where the preference shall be allowed in the order of FN, NRI, NRI's-C and NRI-S, purely based on the merit.

# APPLICATION AS PER THE FORMAT HAS TO BE UPLOADED ALONG WITH THE FOLLOWING MANDATORY DOCUMENTS:

#### I. FOREIGN NATIONALS:

- a. The candidates who seek admission under Foreign National quota are required to route their application (s) through the Indian Embassy in the respective country of residence respective Embassy in India.
- b. The candidate must be a Foreign National, possessing valid foreign Passport who is not of Indian origin.
- c. The admission shall be based on the merit secured in Qualifying Examination i.e., 12<sup>th</sup> Standard / PUC or its equivalent examination as detailed under eligibility criteria.

### Candidate must upload the copies of following documents:

- 1) Duly completed Original Application.
- 2) The Valid Passport of the Applicant.
- 3) Birth Certificate of the Applicant.
- 4) Transcript of 12<sup>th</sup> / PUC or its equivalent education in English medium
- 5) Duly completed Declaration from the Applicant and the Parent / Guardian as per ANNEXURE IV
- 6) Medical Fitness Certificate of the Applicant issued by a Registered Medical practitioner, not below the rank of a Civil Surgeon as per **ANNEXURE**-

VI.

The application along with relevant documents should be **uploaded on or before 31.12.2021 (IST 12.00 midnight).** The original application along with relevant documents and forwardal letter from the Indian Embassy in the respective country of residence in India be submitted at the time of counseling.

#### NON-RESIDENT INDIAN (NRI, NRI's-C and NRI-S):

- a. Non-Resident Indian is a citizen staying outside India continuously for more than 182 days in a year prior to the date of this notification.
- b. Candidates applying under NRI/NRI's-C/NRI-S category should submit recent NRI Status Certificate of the candidate / Parents / Sponsorer, respectively issued by the Indian Embassy of the Country concerned with their seal as per ANNEXURE -I or ANNEXURE –II, as applicable.

c. An Overseas Citizen of Indian (OCI) / Person of Indian Origin (PIO) who is holding a foreign passport will be treated on par with NRI. Necessary proof should be submitted along with the application.

- g. Proof for place of birth of the Applicant.
- h. NEET Score 2021 (conducted by National Testing Agency) of Applicant.
- i. Duly completed Declaration from the Applicant and the Parent / Guardian as per ANNEXURE - IV.
- j. Medical Fitness Certificate of the Applicant issued by a Registered Medical Practitioner, not below the rank of a Civil Surgeon as per ANNEXURE- VI.
