As you are aware the Veterinary Council of India conducts periodical inspection of Veterinary Colleges under the provisions of Section 19 of the Indian Veterinary Council Act, 1984 through duly appointed inspection teams under the laid down regulations. The inspection teams are constituted consisting of experienced faculty members serving in the Veterinary Colleges. The inspection report submitted by the inspection team forms the basis for making any recommendations/ comments in respect of fulfilment of the minimum standards as per Minimum Standards of Veterinary Education Regulations, 2016.

The Council in its meeting held on 13.12.2021 took a decision to revise the experts panel for inspection of the Colleges. For this purpose, it has been decided to invite the nominations from desirous professionals who are willing to serve for the purpose.

It has also been decided to conduct an introductory/ Orientation meeting with all such members whose names will be shortlisted for the Expert list to discuss about the inspection format, inspection mechanism, key areas for inspection, preparation of reports submission of reports, reporting system etc.

Therefore, it is requested to kindly consider and nominate five faculty members of the rank of Assistant Professor with at least 10 years of teaching experience or of the rank of Associate Professor and above whose service can be spared from your College to act as Inspectors with VCI. Kindly provide the details along with contact numbers in the format enclosed herewith, on or before 12.1.2022.
