#### CIRCULAR

**Sub**: Constitution of a Task Force Committee for enabling the fishing communities to operate the Old Bunder Port, Mangaluru, Karnataka

With reference to the meeting held on 03.04.2021 under the Chairmanship of Major P Manivannan, Secretary, Animal Husbandry and Fisheries, Government of Karnataka that was attended by Dr. Rajendra K.V., Deputy Commissioner; Shri Chethan, Superintendent of Police, Coastal Security Police, Mangaluru; Dr. A Senthil Vel, Dean, College of Fisheries and other senior officials, a decision was taken to constitute a Task Force Committee. Accordingly, a Task Force Committee has been constituted for the purpose of enabling the fishing communities to operate the Old Bunder Port.



#### 2. The Terms of Reference (ToR) for the committee is as follows:-

- All fishermen association shall join together and form one single union or consortium to address the issues relating to old Mangaluru Bunder port.
- b) The consortium of fishermen association shall address the issues relating to (a) dredging, (b) berthing, (c) dredge matter disposal, (d) reclamation of the islands with dredged material within the old port, (e) development of the reclaimed area for commercial or any other activity as mutually agreed, (f) marketing, (g) pollution and any other matter relating to smooth functioning of the port
- c) On formation of the consortium of the fishermen association the State Fisheries Department shall hand over all the assets and the land area to the consortium and empower the consortium to take decisions in consultation with all members to address all the issues comprehensively including the financial issues such as levying of fees, collection of revenue, expenditure to be incurred for various developmental activities, operation and maintenance of the port.
- d) The Task Force Committee shall meet atleast once in a month in College of Fisheries, Mangaluru or any other location as decided by the Chairman at a mutually agreed date and time.
- e) The committee may include any other member / expert / representatives as required with the approval of the Chairman.
- f) A sub-committee shall be constituted in College of Fisheries, Mangaluru by the Dean who will co-ordinate the meeting and provide all logistic facilities.
- g) Expenditure towards the meeting with regard to stationary/refreshment/working lunch etc., shall be borne by Department of Fisheries, Government of Karnataka.
