**Item No: 08 Establishment of Super Specialty Companion Animal Hospital at MRS land, Hebbal, Bangalore**

**Resolution**

After thorough discussion and deliberation, the Board has approved the proposal for establishing a Super Specialty Companion Animal Hospital at MRS Land, Hebbal, Bangalore, with an estimated cost of Rs. 39,90,31,750.00. It has been decided to commence the first phase of work, utilizing University funds amounting to Rs. 5.00 crore. Subsequent phases of the project will rely on funds sourced from financial agencies, interested stakeholders, and philanthropists who may wish to contribute and support the initiative. The initiation of the project is subject to government approval. The Board emphasized the importance of allowing for both horizontal and vertical expansion of the Animal Hospital in the future. Additionally, a committee led by the Honorable Vice Chancellor will be formed to develop the necessary procedures for establishing the Super Specialty Companion Animal Hospital.

**Item No.01 Providing power of delegation and financial sanctioning Authority to The Chaiman, ABIC-AM as per MoA**

**Resolution**

After thorough discussion and careful deliberation, the Board of Management has granted permission for the prompt transfer of funds to ABIC-AM at the College of Fisheries, Mangalore. Additionally, the Board has extended the delegation of powers and financial sanctioning authority to the Chairman of ABIC-AM Centre. This is aimed at benefiting entrepreneurs and startups in the fisheries sector, subject to the specified conditions.

- a) To initiate the establishment of a distinct bank account in favor of the Chairman ABIC, Deans (Fisheries) and Assistant Comptroller at the College of Fisheries, Mangalore.
- b) The delegation of financial authority to the Dean encompasses all responsibilities, provided adherence to the KTPP Act, rules, and regulations of the project, as well as compliance with the guidelines set forth by the sponsoring agency allocated to each component. It is imperative to ensure conformity without deviations from one component to another.
- c) To present all project/center vouchers to the audit team upon their visit to College of Fisheries, Mangalore.
- d) To submit the quarterly statement of expenditures to both the funding agency and the Comptroller at KVAFSU, Bidar, for the purpose of reviewing project/center activities.
- e) All credit bills and quotations require countersignature by the Chairman, ABIC-AM and Dean.
- f) Procurement of items must be carried out through the purchase committee, adhering to the designated purchase procedures.
- g) To Remit 10% of the total released amount as institutional charges to the University.
- h) A quarterly review of accounts and monitoring by the Comptroller at KVAFSU, Bidar, is mandatory.
- i) Any audit observation raised by the Auditor in future the Chairman, ABIC-AM Dean & PI of the Project is held responsible for replying answers to Auditors.
- j) To submit the UC/AUC to funding agency as per prescribed format signed by Chairman, ABIC-AM & Dean/PI after completion each financial year.
