### PRESCRIBED QUALIFICATION:

#### **Education Qualification:**

- 1. Degree in Veterinary Science (BVSc).from recognized University established by law.
- Masters Degree (MV.Sc) in Veterinary Microbiology/ Bacteriology/Virology/ Biotechonology/Immunology-Serology and Pathology /Bacteriology /Virology/Preventive Medicine & Epidemiology /Parasitology/Bio Statistics/ /Biochemistry/ Toxicology/ Animal Nutrition/ Avian Diseases.
- 3. The Candidates must possess the recognized Veterinary qualification in the first or second schedule to the Indian Veterinary Council Act-1984 and registered with the state Veterinary Council/Veterinary Council of India.
- 4. The Candidates should have passed Kannada language in the SSLC examination.
- 5. Computer knowledge is preferred.

#### Instructions for the candidates:

- 1. The candidates can download application form from the official website <u>www.kvafsu.edu.in</u> and submit with the processing **fees of Rs. 500**/-(Five Hundred Only) in the form of Demand Draft (D.D) obtained from any Nationalised Banks drawn in favour of The **Comptroller**, KVAFSU, Bidar within the period from **15.07.2024**
- 2. The applications which do not accompany the prescribed fees and Incomplete application forms are liable to be rejected
- 3. The candidates should possess the prescribed qualifications as on the **Last date of submission of application.**
- 4. For all the information furnished / claims made, sufficient and appropriate evidence from competent authority should be enclosed.
- 5. Physically challenged persons should furnish the Medical Certificate from District Medical Board / appropriate authority along with the application.
- 6. Knowledge of Reading and writing Kannada is compulsary.
- 7. Candidates should possess a valid registration of KVC/VCI for the posts under veterinary faculty.
- 8. While filling up of the application form Application in **03** sets should be submitted along with all enclosures including publications in A4 size in spiral bound form
- 9. Age limit: Minimum 18 year to Maximum 40 years.
- 10. Applicants already employed in organizations other than KVAFSU should send their applications through proper channel so as to reach the University within the prescribed date.
- 11. The prescribed essential qualifications are minimum and possessing of same does not entitle candidates to be called for Counselling. The candidates who qualify on screening of applications only be called for Counselling. As such, the candidates applying for the post is advised to fill the form carefully and each and every column of application should be filled up accurately because marks will be awarded on the basis of information supplied by them in each column.
