INTRODUCTION

Karnataka Veterinary, Animal and Fisheries Sciences University, Bidar



Karnataka Veterinary, Animal and Fisheries Sciences University, Bidar was established as per the Karnataka Act No. 9 of 2004 called “The Karnataka Veterinary, Animal and Fisheries University Act 2004” and published in the Karnataka Gazette Extra-Ordinary on the 23rd day of February, 2004. The University is established exclusively for providing education, conduct of research and extension in the areas of Veterinary, Animal, Dairy and Fisheries Sciences in the state of Karnataka. The logo of the University is inscribed with the slogan “**Farmers Friendly and Rural Oriented**”, which emphasizes the importance given to betterment of farming community.

KVAFSU is an autonomous academic institution governed by its Board of Management which regulates the policies of the university in accordance with the provision of act and statutes. The University administration also has the support of the Finance Committee. Academic matters are looked after by the Board of Studies and the Academic Council while Research Council and Extension Education Council decide the research and extension activities of the University, respectively.

The University offers undergraduate Degree programs in Veterinary Science and Animal Husbandry Sciences at six constituent Veterinary Colleges at Bidar, Bengaluru, Shivamogga, Hassan, Gadag and Athani while Dairy Sciences are being offered at Dairy Science College, Bengaluru and Kalaburgi and College of Fisheries, Mangaluru, respectively.

CONSTITUENT COLLEGES OF KVAFSU, BIDAR

I. Veterinary College, Bengaluru



The Veterinary College, Bangalore was inaugurated on 25th July, 1958, by the then Honorable Chief Minister of Karnataka Shri.B.D.Jatti and started functioning in Mysore serum institute, now called Institute of Animal Health and Veterinary Biologicals (IAH & VB).

The present college campus, located in the 196 acres plot was inaugurated by His Highness the Maharaja Shri Jaya Chamarajendra Wodeyar, the Governor of Karnataka, on 6th January 1962 and the same was then affiliated to Mysore University, Mysore. In 1965, the college became the constituent college of the University of Agricultural Sciences, Bangalore under trimester system of education in-line with land-grant system of education. In 2004, after the establishment of Karnataka Veterinary Animal and Fisheries Sciences University (KVAFSU), the college has become the part of the Veterinary University. The College celebrated its golden jubilee year from September 2007 to August 2008.

To meet these challenges, the college has nineteen well equipped departments with highly qualified and skilled staff involved in offering B.V.Sc & AH programme as per Veterinary Council of India regulations. The college is also involved in offering Masters and Doctoral program in seventeen and fourteen disciplines respectively. Besides the college has well equipped hospital at Hebbal and Yelahanka with state of art facility for teaching, research as well as for to serve the farming community. The college has instructional farm that includes dairy, sheep, piggery, poultry farm and experimental small animal unit.

II. Veterinary College, Bidar



The College was established in 1984 under University of Agricultural Sciences Bengaluru and later became a constituent college of University of Agricultural Sciences, Dharwad during 1986 and subsequent a constituent college of KVASFU in April 2005 located at Nandinagar, Kamatana Road, Bidar

The College is offering B.V.Sc. & A.H degree programme as per Minimum Standard of Veterinary Education (MSVE) 2016 regulations of Veterinary Council of India, New Delhi for the students admitted from the academic year 2017-2018. The College is having 17 teaching departments including Veterinary Clinical Complex (VCC) and Livestock Farm Complex (LFC). In addition post-graduate (M.V.Sc.) and Doctoral degree programme is also offered in selected subjects from academic year 1995-96 in accordance with the ICAR guidelines.

III. Veterinary College, Shivamogga



Shivamogga is endowed with rich natural resources including animal genetic resources, heritage of culture, traditional and social systems and is being considered as lead centre in education activities. Veterinary College, Shivamogga recognized under Veterinary Council of India, New Delhi, was

established in the Year 2006 and started functioning in the NSS building of the Sahyadri Science College on 11.09.2006.

Presently, the College is functioning in the main campus in an area of 172.18 acres at Vinobangara near Sominakoppa, Shivamogga. with well established infrastructure. In this college, adequate measures are taken to assure quality education, as the college is governed by the requirements of Veterinary Council of India and guidelines of the KVAFSU, Bidar.

The College is offering B.V.Sc. & A.H degree programme as per Minimum Standard of Veterinary Education (MSVE) 2008 and 2016 regulations of Veterinary Council of India, New Delhi for the students admitted from the academic year 2009-2010 and 2016-17 onwards respectively. The College is having 17 teaching departments including Veterinary Clinical Complex (VCC) and Livestock Farm Complex (LFC). Master's degree programme (M.V.Sc) are being offered in 13 disciplines and Doctoral Degree in 2 discipline.

IV. Veterinary College, Hassan



Veterinary College, Hassan (HVC), emerged as the fourth constituent Veterinary College of KVAFSU, Bidar on 16th August 2007. The HVC is located at the fringes of Hassan city, sprawling across about 80 acres the beautiful campus of HVC has been blessed with fertile soil, lakes, counters and farm land. Magnificent main building has been one of the unique government structures of the district coupled with an adjacent state-of-the art Veterinary Hospital. The beautiful campus of HVC has hostels (boys and girls), well equipped sports complex with pavilion for indoor and outdoor games including multi-gym facility, livestock farms, residential quarters and guest house buildings. The college offers undergraduate B.V.Sc. & A.H. degree programme as per Veterinary Council of

India (VCI) standards. The HVC has 18 departments and equipped laboratories to meet the requirements of the minimum standards of veterinary education (MSVE). In addition post-graduate (M.V.Sc.) degree programme is also offered in accordance with the ICAR guidelines.

V. Veterinary College, Gadag



Gadag is a place primarily known for dry land agriculture. The place inherits its pride of place in the fields of culture, tradition, music and printing. Veterinary College, Gadag recognized under Veterinary Council of India, New Delhi, was established in the Year 2017 and started functioning in own building on 25.09.2017 with initial intake of 50 students.

Presently, the College is functioning in the main campus in an area of 162 acres on Hombal road, Gadag. with well established infrastructure. In this college, adequate measures are taken to assure quality education, as the college is governed by the requirements of Veterinary Council of India and guidelines of the KVAFSU, Bidar.

The College is offering B.V.Sc. & A.H degree programme as per Minimum Standard of Veterinary Education (MSVE) 2016 regulations of Veterinary Council of India, New Delhi for the students admitted from the academic year 2017-2018. The College is having 17 teaching departments including Veterinary Clinical Complex (VCC) and Livestock Farm Complex (LFC).

VI. Sri Bahurao Deshpande Veterinary College, Athani, Belagavi



Shri. Bahurao Deshpande Veterinary College Athani was sanctioned in the year 2010 by Government of Karnataka and is a constituent college of Karnataka Veterinary, Animal and Fisheries Sciences University, Bidar. It is the first and only Rural Veterinary College in the state of Karnataka. The College was inaugurated by the Hon'ble Chief Minister of Karnataka Shri. Siddaramaiah on 11 th August 2023. The campus is spread over 211 acres of land and is located at Kokatnur Village at 18Kms from Athani of Belagavi District. Athani is among the remotest taluks in the state, situated at 150 km from the district headquarters of Belagavi, around 60 km from Sangli, 75 km from Vijayapura and 125 km from Bagalkot.

The College is offering B.V.Sc. & A.H degree programme as per Minimum Standard of Veterinary Education (MSVE) 2016 regulations of Veterinary Council of India, New Delhi for the students admitted from the academic year 2024-25. The Campus has an elegant main building housing various departments, administrative offices, and classrooms; Veterinary clinical complex with various clinical departments; Separate Boys and Girls Hostel; Library Building, Staff Quarters, ILFC Block, Post-mortem Building, agriculture land, animal houses etc.

GUIDELINES AND INSTRUCTIONS FOR ADMISSION TO B.V.Sc. & A.H., B.Tech (D.Tech) AND B.F.Sc., DEGREE PROGRAMMES UNDER NON-RESIDENT INDIAN (NRI) or OVERSEAS CITIZEN OF INDIA (OCI) or PERSON OF INDIAN ORIGIN (PIO) / NON RESIDENT INDIAN CHILDREN /NON-RESIDENT INDIAN SPONSORED CANDIDATES AT KVAFSU, BIDAR FOR THE ACADEMIC YEAR: 2025-26

General Information to the Applicants:

1. The applicants/candidates should have attained the age of **17 Years** and should not have completed **25 years** of age as of **31.12. 2025**. No relaxation of the minimum and maximum age limit is permissible on any grounds whatsoever.
2. The admission shall be based on the merit secured in Qualifying Examination *i.e.*, 12th Standard/ Pre-University Course (PUC), or its equivalent examination (on regular mode) and/or the entrance examination prescribed for admission to a particular degree programme.
3. If a candidate has not received the original marks card of Qualifying Examination for the Academic Year **2025** from the concerned Institutions/boards, then the candidate should obtain the signature of the Principal of the institution where candidate has passed 2nd PUC/12th Standard examination on the provisional marks card. *Internet downloaded marks statement printouts are not acceptable.*
4. In case of International applicants/candidates, if the qualifying examination is other than 10+2 or 12th Standard of India, then the certificates/ transcripts of equivalent qualifying examination (10+2 or 12th Standard) must have been recognized and approved by the Association of Indian Universities (AIU). Candidates must submit an EQUIVALENCE CERTIFICATE issued by the AIU. Candidates may refer to the Website of AIU for more information about the Application procedure for obtaining Equivalence Certificate.
5. Applications submitted, which are in proper order shall be accepted and mandated till finalization of the programme applied for. The category once filled in the application form shall be final and cannot be changed at later stage.
6. The candidates must ensure that duly completed Application along with relevant documents must be uploaded ONLINE on or before **25.08.2025 (Until 23:59:59 IST)**. Applications without the relevant documents shall be summarily rejected.
7. The hard copy of the original application uploaded online and relevant original documents must be submitted at the time of offline counseling for verification (after online submission, the original application along with relevant documents uploaded must be downloaded and printed).
8. If any of the information provided in the application or documents submitted is found false either during counseling or after admission or at any point of the degree programme admitted, such candidates will be debarred from the admitted course or legal action will be initiated. In such cases the entire amount of Course fee/Institutional economic fee/ other regular fees paid shall be forfeited.

9. Economic fees, admission fees, tuition fee, any other fees and charges will be applicable as per instructions issued by the University from time to time.
10. Online notification of the candidate's eligibility for offline counseling or the candidates merely attending the offline counseling process shall not confirm their right of admission to the course applied for at KVAFSU, Bidar.
11. The decision to fill or not to fill and modalities to fill the seats remaining vacant due to non-availability of eligible candidates by NRI or OCI or PIO, NRI's-C and NRI-S shall rest with the university.
12. In the event of student discontinuing or cancelling his admission in the middle of the degree programme, the student has to pay the processing fees as stipulated by the University for discontinuing or cancelling his/her admission.
13. **DISCLAIMER:** The statements made and information contained in the Notification / Prospectus is of general nature for the knowledge of the candidate seeking admission to various programmes of the university constituent and affiliated colleges. The information contained herein is believed to be correct at the time of publication/uploading. 14. **JURISDICTION:** Any dispute/litigation arising out of anything concerned with the university and its activities, including admissions/operation of Academic & Hostel rules shall be subject to the Legal jurisdiction of the Hon'ble High Court of Karnataka, Kalaburgi Bench, Karnataka.

Meaning of Terminologies for admission process at KVAFSU, Bidar:

I. NON-RESIDENT INDIAN:

In the case of the general public, an individual being Indian citizen or person of Indian origin is said to be Non Resident Indian(NRI) in any financial year, if candidate satisfies both of the following conditions: (i) Candidate resides in India for less than one hundred and eighty two days (182) during the previous financial year or who stays outside India for employment or for carrying on business or vocation outside India, or who stays outside India for any other purpose indicating his intention to stay outside India for an uncertain period. (ii) An Indian Citizen stay in India for less than 365 days during the four preceding previous financial years and less than 60 days in that financial year.

II. NON-RESIDENT INDIAN (NRI) STUDENTS:

- a. Non-Resident Indian students are Indian Nationals studied abroad. They must have had at least 3 (three) years of education in any foreign country during the last 6 (six) years and must have passed the qualifying examination (12th standard or equivalent) from abroad only and in the college/ institutes affiliated to Boards of Secondary Education or Universities located in India.

- b. This includes the Indian students studying in the schools or colleges situated in foreign countries even if they are affiliated to Boards of Secondary Education or Universities located in India, but will not include students studying in those schools or colleges (situated in India) and affiliated to the Boards of Secondary Education or Universities of the foreign countries.
- c. In case an intervening period/gap is involved, a certificate/affidavit from a Class-I Gazetted Officer/Notary Public for the entire intervening period/gap showing the candidate's preoccupation after leaving the Institution last attended shall be produced by such applicants.

III. OCI / POI CARDHOLDERS

The Ministry of Home Affairs vide Notification dated 4th March 2021 specified the rights to which an OCI or POI cardholder shall be entitled under the Citizenship Act, 1955. Clause (4) (ii) of the said Notification reads as under: “(4) parity with Non-Resident Indians in the matter of, (ii) appearing for the all India entrance tests such as National Eligibility cum Entrance Test, Joint Entrance Examination (Mains), Joint Entrance Examination (Advanced) or such other tests to make them eligible for admission only against any Non-Resident Indian seat or any supernumerary seat:

Provided that the OCI/POI cardholder shall not be eligible for admission against any seat reserved exclusively for Indian citizens.

The above Notification provides the following Explanation: “The OCI Cardholder (including a PIO card holder) is a foreign national holding passport of a foreign country and is not a citizen of India.” Similarly, the PIO cardholder and foreign nationals shall not be eligible for admission against any seat reserved exclusively for Indian citizens.

IV. NON-RESIDENT INDIAN'S CHILDREN (NRI's-C):

- a. Children of NRI parents/guardians are those who have at least one of their parents/guardians residing abroad as an NRI. In case of no parents, the guardian must be an NRI residing abroad and must regard the applicant as his/her ward, as evidenced by an affidavit demonstrating interest in the student's affairs.

V. NRI SPONSORED STUDENTS (NRI-S):

- a) The Sponsor financing the education of a student must be an NRI and/or blood relation such as spouse, children (natural/adopted/foster), siblings, paternal uncle/aunt, maternal uncle/aunt, paternal grandfather/grandmother, and maternal grandfather/grandmother, paternal and maternal cousins.
- b) The Sponsor possessing a student / visiting visa or temporary visa of any nature from other countries is not eligible to sponsor. The Sponsor must produce the proof of the annual income sufficient to support the course of study of his/her ward.

VI. KARNATAKA DOMICILE:

Eligibility for Karnataka domicile is determined based on fulfillment of one of the following criteria:

- a. The candidate should have studied and passed in one or more Government or Government recognized educational institutions located in the State of Karnataka for a minimum period of SEVEN academic years commencing from 1st standard to 2nd PUC / 12th standard as on 1st July 2025, in which the CET is held and must have appeared and passed either SSLC/10th standard or 2nd PUC/12th standard examination from Karnataka State. In case of the candidate who had taken more than one year to pass a class or standard, the years of academic study is counted as one year only.
- b. The candidate should have studied and passed either 1st and 2nd Year Pre-University Examination or 11th and 12th standard examination within the State of Karnataka from an Educational Institution run or recognized by the State Government and that either of the parents should have studied in Karnataka for a minimum period of SEVEN years.

Eligibility Criteria and Admission Process:

1. The eligibility for the seats under for B.V.Sc. & A.H. Degree Programme remains same as per the Academic Information Regulation Governing B.V.Sc. & A.H. Degree Programme under MSVE 2016 of Veterinary Council of India, where in candidate must have passed 12th Standard/PUC or its equivalent as a qualifying examination comprising of Physics, Chemistry, Biology/ Biotechnology and English as subjects with a minimum score of 50% aggregate marks in Physics, Chemistry, Biology/ Biotechnology and English.
2. Admission to B.V.Sc. & A.H. degree programme under the **NRI** or **OCI** or **PIO & NRI's-C category** shall be based on the merit of **NEET-2025 Score** (entrance examination conducted by the National Testing Agency).
3. The selection for seats under NRI-S (Karnataka Domiciles only) for B.V.Sc. & A.H. Degree Programme shall be based on the **K-CET Veterinary ranking 2025** conducted by the Karnataka Examination Authority (KEA), Bengaluru. Whereas, selection for seats under NRI-S (All India) shall be based on the **NEET ranking 2025** conducted by the National Testing Agency. Karnataka Domiciles candidates who have not appeared for K-CET can opt for seat under NRI-S (All India) based upon **NEET ranking** and if such candidate is admitted, they have to pay fees prescribed for NRI-S (All India) category.
4. Candidate must have passed 12th Standard/PUC or its equivalent as a qualifying examination comprising of Physics, Chemistry, Mathematics, Biology (Botany & Zoology) and English as subjects for B.Tech (D.Tech) and B.F.Sc., degree programme.
5. Admission of candidates to B.Tech (D.Tech) and B.F.Sc., degree programme under the **NRI** or **OCI** or **PIO & NRI's-C category** shall be based on the merit scored in 12th Standard/PUC or its equivalent qualifying examination comprising of Physics, Chemistry, Biology (Botany

& Zoology) and Mathematics as subjects with English as the medium of instruction.

6. The selection of the seats under NRI-S (Karnataka Domiciles only) for B.Tech (D.Tech) and B.F.Sc., Degree Programme shall be based on the **K-CET Agriculture ranking- 2025** conducted by the Karnataka Examination Authority (KEA), Bengaluru. Whereas, selection for seats under NRI-S (All India) shall be based on the average marks scored in Physics, Chemistry, Mathematics and Biology in 12th Standard/ PUC, or its equivalent examination. Karnataka Domicile candidates who have not appeared for K-CET may opt for seat under NRI-S (All India) based upon the merit scored in 12th Standard/PUC or its equivalent qualifying examination comprising the subjects of Physics, Chemistry, Biology (Botany & Zoology) and Mathematics and in case if such candidate is admitted, they have to pay fees prescribed for NRI-S (All India) category.
7. Candidates applying under **NRI or OCI or PIO, NRI's-C & NRI-S** category should submit the recent NRI Status Certificate of the Candidate/Parents/Sponsor, respectively, issued by the Indian Embassy of the Country concerned with their seal as per **ANNEXURE-I** (Certificate signed by the Indian Consulate General/ Indian Embassy with seal - issued within last 06 months from the date of issue of the notification.)
In case of OCI / PIO Candidate/Parents/Sponsor, Valid Overseas Citizen Certificate (OCI) / Person of Indian Origin (PIO) Card/certificate along with valid Passport of the Candidate/Parents/Sponsor.
8. Parents/Guardians who are Overseas Citizen of India (OCI) or Person of Indian Origin (PIO), who is holding a foreign passport, shall be treated on parity with NRI. Necessary proof should be submitted along with the application.
9. The successful candidates shall be **admitted in the order of preference**: Non-Resident Indian (NRI) or Overseas Citizen of India (OCI) or Person of Indian Origin (PIO)/Non-Resident Indian's Children (NRI's-C)/ NRI Sponsored (Karnataka Domicile only), respectively. Further, subject to availability of vacant seats if any such seats shall be filled under NRI Sponsored (All India).
10. Depending on the availability of seats, the successful candidates may exercise their option for the college at the time of counseling -cum admission. Allocation of the colleges shall be in the order of **NRI or OCI or PIO, NRI's-C & NRI-S**, based on the merit.
11. The candidates called for counseling must come prepared to pay the Institutional Economic Fee and other regular fees online (RTGS / Net Banking) and must remit such fees at the time admission. In case of failure to remit the prescribed fees at the time admission such candidates shall forfeit their opportunity for admission, and such seat shall be allotted to the next candidate in the merit list.
12. **The Institutional Economic Fee, in US Dollars or its equivalent Indian Rupees, must be paid at the time of admission/registration per annum. Foreign currencies in the form of currency notes or cheques will not be accepted.**
13. Upon securing admission, candidates/students must pay the requisite fees for their admission category throughout the programme, even if their status changes for example NRI- to Non-NRI,

to Indian citizen or OCI/PIO to Indian citizen.

14. After scrutiny of the applications/successful completion of the counseling process, the University shall issue a 'Provisional Admission Letter' to eligible candidates for the purpose of obtaining a 'Student Visa' from the Indian Consulate/Embassy.
15. All International students will require a 'Student VISA' endorsed to Karnataka Veterinary, Animal and Fisheries Sciences University (KVAFSU), Bidar for joining full-time courses.
16. Admission of **NRI** or **OCI** or **PIO**, **NRI's-C** & **NRI-S** students will be confirmed ONLY after verification of all the relevant original certificates/testimonials, and payment of the required fee and other such requirements, if any, shall be determined by the university from time to time.
17. The **NRI** or **OCI** or **PIO**, **NRI's-C** & **NRI-S** students must abide by the Academic Regulations of KVAFSU, Bidar and the code of conduct as applicable to Indian students enrolled for the degree programme from time -to time.

23. In case of applicants seeking admission in B.Tech (D.Tech) & B.F.Sc., upper limbs must be normal. More than 70% of disability in lower limb is not eligible.
24. In case of applicants seeking admission in B.V.Sc. & A.H. course, a candidate shall not be allowed admission if he or she suffers from the following disabilities, namely;
 - i) Disability of total body including disability of chest or spine more than 50%.
 - ii) Disability of lower limb of more than 50%.
 - iii) Disability of upper limb.
 - iv) Visually handicapped candidates and those with hearing disability.
 - v) Candidates with progressive diseases like myopathies etc.
 - vi) Disabilities which otherwise would interfere in the performance of the duties of a veterinarian.

The disability shall be certified by a duly constituted and Government authorized Medical Board comprising of at least three specialists out of which two shall be of the specialty concerned and the candidate has to present himself/ herself before the Medical Board. The last valid disability

certificate of the candidate from a Medical Board shall not be more than three months old from the date of submitting his or her certificate (last date of application for admission).

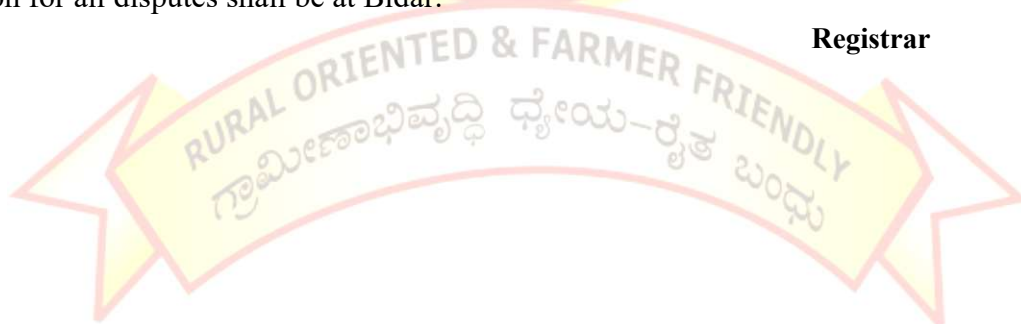
